Adam King, District Manager, informed the supervisors that the Board of Water and Soil Resources allows districts to use 100% of Conservation Cost-Share Grant funds for technical assistance. A motion was made to approve and sign Technical Assistance Option for the FY19 Board of Water and Soil Resources Conservation Cost-Share Grant.

District Cost-Share Contract 2018-05 (Hahn) Payment

Adam King, District Manager, informed the supervisors that Eric Hahn of Hayfield, MN is requesting payment of District Cost-Share Contract 2018-05 for a grassed waterway. Total eligible expenses came to \$9,279.18. Hahn is receiving federal funding for this project, and is requesting \$1,609.42 to reach 75% cost-share between state and federal sources. A motion was made to approve payment in the amount of \$1,609.42 for District Cost-Share Contract 2018-05 to Eric Hahn for the installation of a grassed waterway coming from the FY17 SWCD Local Capacity Services Grant.

FY19 Non-Structural Practices Cost-Share Policy

Adam King, District Manager, informed the supervisors that the Board of Water and Soil Resources requires that a form must be filled out identifying the priorities that are targeted for the best measurable results if a district is to provide cost-share for non-structural practices. King explained that for FY17 the district decided to target the Middle Fork Zumbro River for non-structural practices with the flat EQIP rate. The supervisors expressed that they would like to continue to use funds for all non-structural practices (cover crops, nutrient management, no-till), and want to go with a percentage-based cost-share. Supervisors discussed targeting canning crops, but many might not have canning crops for three years, and have more than 50 acres, and discussed targeting Wellhead Protection Areas.

There was no Other New Business.

Correspondence & Staff Report

Adam King, District Manager, informed the supervisors that the Currier Brothers feedlot project was not selected for funding through the Regional Conservation Partnership Program, and that Blaine Delzer, District Technician, is working on a Clean Water Fund Grant application to fund the project. King presented a letter from the Minnesota Counties Intergovernmental Trust showing a dividend of \$1,480.00 for 2018, and an invitation from the Dodge County Farm Bureau to their 100th anniversary.

Supervisor Reports

Minnesota Association of Soil and Water Conservation Districts (MASWCD) – Bill Thompson, District I Supervisor, reported attending the MASWCD meeting in Grand Rapids, MN where the House and Senate versions of the Federal Farm Bill were compared, and Kurt Beckstrom reported representing Minnesota at the National Association of Conservation Districts meeting. A map of Clean Water Fund grants between 2010 and 2015 separated out by counties was reviewed. There was a presentation on forestry, learning that 75% forest cover is needed to maintain lakeshores. Troy Daniels, State Conservationist, Natural Resources Conservation Service, was introduced and spoke about the reorganizational plan.

Southeast Minnesota Association of Soil and Water Conservation Districts (SE MASWCD) – Bill Thompson, District I Supervisor, reported that there will be a joint meeting with the employees on Monday, September 17, 2018 at the Tau Center on Winona State University Campus.

<u>Dodge County Feedlot Advisory Committee</u> – Glenn Hahn, District V Supervisor, reported that there was no meeting and there are no meetings currently planned.

One Watershed One Plan (1W1P) – Root River Watershed – Glenn Hahn, District V Supervisor, reported that there was no meeting and there are no meetings currently planned.

<u>Dodge County</u> – Glenn Hahn, District V Supervisor, and Bruce Freerksen, District II Supervisor, reported attending the Dodge County Commissioners meeting on Tuesday, August 07, 2018 to present the 2019 budget. Hahn indicated to the Commissioners that while the district is not asking for an increase for 2019, a cost of living increase may be asked for in 2020.

<u>Soil Health Field Day</u> – Glenn Hahn, District V Supervisor, reported that there is a soil health field day at the Rodney Krell Family Farm 2.5 miles north of Blooming Prairie put on by CFS, Land O' Lakes Sustain, Hormel Foods, and the Mower Soil and Water Conservation District.

<u>Cedar River Watershed District (CRWD)</u> – David Livingston, District IV Supervisor, reported attending the CRWD meeting on August 15, 2018 where they held a public hearing for their 2019 levy, including \$250,000 for administration and \$100,000 for projects. Two projects were discussed, including one proposed road grade raise and culvert downsize. Ongoing discussions with the Minnesota Pollution Control Agency on bacteria continue, and there are 22 CRP contracts re-enrolling.

One Watershed One Plan (1W1P) – Cedar River Watershed – David Livingston, District IV Supervisor reported that the September meeting was cancelled, and the next meeting will be held on Wednesday, October 03, 2018.

Resource Conservation and Development (RC&D) – Bruce Freerksen, District II Supervisor, reported that he was unable to attend the meeting held on Monday, July 23, 2018.

Southeast Area Soil and Water Conservation District Technical Support Joint Powers Board – Larry Scherger, District III Supervisor, reported attending the meeting on Tuesday, July 31, 2018 where they discussed partnering with the Southeast Minnesota Water Resources Board for a shared director, and approved the Regional Conservation Partnership Program feedlot projects. There will be a special meeting in August to discuss health insurance and feedlot projects.
