Partner Agency Reports

Natural Resource Conservation Service Report

Brian DeVetter, District Conservationist, Natural Resource Conservation Service reported working on CRP, EQIP and CSP. DeVetter is still splitting time between Mower and Dodge Counties, and has inspected recently installed projects. The EQIP sign-up is moving forward, with applications coming in for FY18. There is a lot of prep work to be completed before the Mid-August EQIP deadline. CRP is currently halted, and only those contracts signed before May 3rd will be accepted into the program. There are 8 new CRP contracts in Dodge County. CSP is using a new tool, and has a tight deadline for signup. There will be a Soil Health Field Day at the Finnegan, Hamilton and Cotter farms in Mower County. The Local Work Group will not be held this year, and must be completed by May 1st 2018. ACEP funding will run out next year (2018), and the

Treasurer's Report

Approval of the Treasurer's Financial Statements and Payment of New Bills — Glenn Hahn, Treasurer, reported and presented the April 2017 Revenues, noting that there was good tree sales and state income, with \$24,445.08 coming in April. The Expenditures in April were \$36,343.89. The Balance Sheet, Grant Expenditures, and Aging Summary were discussed.
