District Conservationist's Report

Brian DeVetter, District Conservationist, NRCS, reported that they have ongoing construction on a six basin system EQIP project, but are running into complications with a gas line, so guidelines are important to follow. They also have three animal mortality facilities going in and a gulley erosion request. In total there were eight EQIP applications and tomorrow is the cutoff. They are also doing field checks/certifications for CSP and should be finishing up in October. The area needs assistance and Brian has been assigned to some area duties.

<u>Zumbro Watershed Partnership</u> – Bill Thompson, District 3 Supervisor, and Adam King, District Manager, attended the October 09, 2014 ZWP Meeting and reported the following meeting items:

- The ZWP received and are working on an LCCMR grant for recreational and learning sites along the Zumbro River. 20X30 inch panels will be posted on trails and river access.
- The ZWP is planning their H3: Healthy Lands, Healthy Waters, Healthy Communities workshop for 2015.

<u>Resource Conservation & Development</u> – Don Heser, District 2 Supervisor, attended the RC&D meeting on September 29, 2014 and reported the following meeting items:

- The LCCMR Invasive Species Grant with Steele has been canceled. The U of M was going to use goats at a nature center and is now looking into comprehensive plans.
- The RC&D is also working on a forest restoration site near the Root River near Stewartville. The site is being thinned and pruned to allowing for an oak savanna restoration.

Managers' Report

Adam King, District Manager, reported on presenting on raingardens at Dodge Center Lions Club meeting. The SWCD board expressed interest in urban BMP's and Adam said he found much
