#### **2023 Dodge Cover Crop Application Contract**

Adam King, District Manager, presented a final draft of the 2023 Dodge Cover Crop Program Landowner Agreement, which King explained outlines the responsibilities of the landowner and the District, and includes a payment rate of \$5.00 per acre for every acre over 20 acres. King also explained the contract includes language to prevent fall tillage, except for in cases where canning crops were harvested and large ruts were left in the field, knifing in manure / fertilizers, and headland areas where machinery was parked during harvest. The supervisors discussed the contract and agreed that the addition of the landowner's address would be helpful; a motion was made to approve the 2023 Dodge Cover Crop Application Contract with the addition of the landowner's address, and approving Adam King, District Manager, to execute the contracts with landowners on behalf of the Dodge Soil and Water Conservation District.
