Minnesota Board of Water and Soil Resources (BWSR) Report

Copeland noted that there will be a bump in cost-share dollars allocated from the MN BWSR due to the amounts being annually budgeted in general fund dollars. definitive news will come in the next month or so. Lastly, Copeland relayed that the FY24 and FY25 grants for the watershed-based implementation funding will total in excess of \$76.5 Million.

Natural Resource Conservation Service Report

Nathan Bird, District Conservationist, United States Department of Agriculture (USDA) - Natural Resource Conservation Service (NRCS), reported having done a great deal of construction in the last few weeks, specifically with the waterway projects, noting that approximately 9,760 feet of waterway has been installed for a sum near \$31,000.00 in funds out the door to landowners. Bird added the emergency having and grazing program with FSA is keeping them fairly busy, and a soil conservationist position opened August 15th for the NRCS and will be open for 10 days or so.

Approval of the Treasurer's Financial Statements, Payment of New Bills

Glenn Hahn, Treasurer, presented the July 2023 Financial Report, including the Balance Sheet covering what is in our checking and savings, Revenues of \$110,666.37, Expenditures of \$43,742.91, the General Ledger and Aging Summary, with a payables total of \$14,012.20. The supervisors discussed the treasurer's report. A motion was made to approve the July 2023 Treasurer's Report and bills on the Aging Summary, for a payables total of \$14,012.20.

Cell Phone Policy

Adam King, District Manager, presented a quote from Verizon Wireless for the addition of a staff phone and data to the current plan; King explained that currently Jessica Klingfus, District Technician, is the only staff member that routinely works in the field and with contractors and/or landowners, and is therefore requesting the device and access for her only. The supervisors agreed to approve the addition of the phone and line for Jessica Klingfus, and a motion was made to approve Adam King to sign up for Verizon's 4G Custom Business Unlimited Plan at \$51.35/month, and purchase a Samsung S23 mobile device for \$49.99 along with any associated fees.

Server and Computer Upgrade Proposal

Adam King, District Manager, recalled from previous discussion that the district server along with two staff computers were purchased in 2017, and two other staff computers were purchased in 2016 and 2014, adding that, generally, computers and servers should be replaced approximately every five years. With the ever-changing status of deals and incentives for purchasing this type of equipment, King presented a staff recommendation to set a technology upgrade threshold in the amount of \$10,000.00, for the purpose of purchasing a new server and two staff computers. The supervisors discussed the process of purchasing new computers and/or a new server, and agree that working with an amount will help Scott from TechRight Services to purchase items thoughtfully and provide some flexibility. A motion was made to approve the purchase of a new server and two staff computers within the budget set of \$10,000.00 for these technology upgrades.

Cedar Watershed Cost-Share Contract CWW-CRP-DC-01 (Yentsch) Encumbrance

Stuart Yentsch of Blooming Prairie, MN has requested to encumber funds for the CRP Incentive payment through the Cedar Wapsipinicon Watershed Based Implementation Funding, for the establishment of a CP23a Wetland Restoration in Section 2 of Westfield Township. The practice incentive payment for this practice is \$80/Acre/Year and the total Yentsch is requesting to encumber for his 1.87 acres over 15 years is not to exceed \$2,244.00. District Cost-Share Contract 2023-01 (Meirick) Payment

Tim Meirick of Dodge Center, MN has requested payment from the Dodge Soil and Water Conservation District for Cost-Share Contract 2023-01 for the installation of a 412 Grassed Waterway in Section 32 of Concord Township. Dave Chicos was authorized to encumber \$30,821.29; the total cost for practice installation was \$129,669.71, therefore Dave Chicos is requesting 5% of the total project cost, and 90% when combined with federal funds, not to exceed \$6,615.98. Zumbro Watershed Cost-Share Contract 2022WAGZ-DC-06 (Fay) Amendment 2

Marlin Fay of Grand Meadow, MN has requested an additional amendment to the Zumbro Watershed Cost-Share Contract 2022WAGZ-DC-06. The original estimated cost of the practice was \$7,661.50 with 75% of the total cost encumbered in December of 2022, not to exceed \$5,746.13.
