# **Natural Resource Conservation Service Report**

Nathan Bird, District Conservationist, United States Department of Agriculture (USDA) - Natural Resource Conservation Service (NRCS), reported on the Continuous Conservation Reserve Program (CRP) sign-up, with its batching period closing March 15, 2024, and approval of contracts beginning in fall 2024. The USDA has announced a General CRP sign-up, with a deadline of March 29, 2024. The Minnesota NRCS has sent out a Notice of Funding Opportunity and \$35 Million/year is available to many of their conservation partners. The District Conservationist in Steele County is on assignment in St. Paul, so Bird is currently serving in Steele and Dodge Counties. Pheasants Forever is hiring a seasonal position that has a possibility of being housed in the Dodge Center Field Office.

# **Treasurer's Report**

# Approval of the Treasurer's Financial Statements, Payment of New Bills

Glenn Hahn, Treasure, presented the February 2024 Financial Report, including the Balance Sheet covering what is in the accounts, revenues of \$14,120.52, expenditures of \$26,428.32, the general ledger, and aging summary with a payables total of \$7,248.74. The supervisors discussed the treasurer's report. A motion was made to approve the Feb. 2024 Treasurer's Report, and pay bills on the aging summary for a payables total of \$7,248.74.

#### **Unfinished Business**

#### 2024 Cover Crop Program

Adam King, District Manager, presented a Request for Expressions of Interest that would be sent out to vendors for applying cover crops to cropped fields according to the USDA – NRCS 340 Cover Crop standards. The proposed rates would be \$10/acre for non-incorporated methods, and \$22/acre for incorporated methods. The vendor would agree to not charge the landowner for labor.

Mark Moenning, Dodge County Resident, and Tom Pyfferoen, Dodge County Resident, expressed concerns with the proposed program, and felt that some landowners are unlikely to adopt cover crop practices without major incentives, or at little to no cost to the landowner or producer. The supervisors, Moenning, and Pyfferoen discussed the two potential programs, including continuing to provide the seed and labor for applying cover crops at little to no cost, and providing payment to interested vendors to cover the cost of labor.

The supervisors came to a consensus that the Dodge Soil and Water Conservation District will again provide the service of applying cover crops to fields for \$5/acre and covering the remaining seed and labor costs. The supervisors instructed King to work with Moenning and Pyfferoen on the Dodge County Cover Crop Program.

#### Personnel Committee Recommendations

Adam King, District Manager, informed the supervisors that the Administrative Professional position was reposted and is open until filled. Six additional candidates have applied for the position, bringing the total applied to 17. The Personnel Committee has reviewed and ranked the applicants, and has decided to move forward with interviews for the top five candidates.

## **New Business**

## **Equipment Purchase**

Adam King, District Manager, informed the supervisors that Dylan Jones, Frontier Precision, was invited to the office and gave a demonstration of new survey equipment. King explained that our current survey equipment was purchased seven years ago, and that the controller is a tablet that is now out of date and will soon no longer be receiving updates. The new R12i (receiver) has considerable upgrades over our current R8s (receiver). The quotes for a new receiver and controller are in the upper \$30,000s. King reminded the supervisors that it is not currently in the budget, but wanted to get the replacement of our survey equipment in front of them for when the request comes in.

King also presented quotes for a drone. The purchase of a drone is in the 2024 budget. The supervisors expressed interest in wanting Supervisor Alberts input on the drone, and tabled the discussion.

# Zumbro Watershed Cost-Share Contract 2024WAGZ-DC-02 (Bordleon) Encumbrance

Lee Roy Bordelon of Mantorville, MN has requested cost-share assistance from the Dodge Soil and Water Conservation District for a 351 – Well Decommissioning project of in Section 11 of Mantorville Township. The estimated cost for the project is \$4,100.00, and is requesting to encumber up to 75%, not to exceed \$3,000.00. A motion was made to approve and encumber Zumbro Watershed Cost-Share Contract 2024WAGZ-DC-02 for Lee Roy Bordleon to install a Well Decommissioning in Section 11 of Mantorville Township at 75% of the total cost of the project, not to exceed \$3,000.00.

## Zumbro Watershed Cost-Share Contract 2023WAGZ-DC-08 (Boyum) Payment

Clair Boyum of Kenyon, MN has requested payment from the Dodge Soil and Water Conservation District for Zumbro Watershed Cost-Share Contract 2023WAGZ-DC-08 for the installation of a 638 – Water and Sediment Control Basin (WASCOB) in Section 27 of Concord Township. Boyum was authorized to encumber \$9,820.80 with the total cost for practice installation being \$7,304.00, and is requesting 90% of the total project cost, not to exceed \$6,573.60. The remaining \$3,247.20 will be made available for other projects. #### Glenn Hahn, District V Supervisor

Glenn Hahn, District V Supervisor, reported attending the Root River Policy Advisory Committee meeting on February 26, 2024, and that the Policy Advisory Committee meeting on Policy Advisory Committee reviewed and approved changes to their Cost-Share Program Policy, including additions to the well sealing practice. It was noted that the Volunteer Nitrate Monitoring Network data show that Nitrate concentrations in Dodge County have been going down. Grant budgets were reviewed, and cost-share projects were presented. Minnesota Soil Health Coalition staff were present at the meeting and spoke to the committee. Staff gave a presentation on feedlots.

### **David Livingston, District IV Supervisor**

David Livingston, District IV Supervisor, reported attending the Cedar River Watershed District (CRWD) / Mower Soil and Water Conservation District (SWCD) Joint Meeting where there were presentations on conservation projects, septic projects, and well testing in Mower County with over 130 private wells tested and many results coming back high for nitrates. The CRWD accepted a \$5,000 quote for their 2023 Financial Audit, and are looking to work on soil health with Mower County funds and holding a five-year contract with landowners. Both boards expressed interest in another conservation tour in the fall.
