### **Partner Agency Reports**

#### **Natural Resource Conservation Service Report**

Nathan Bird, District Conservationist, United States Department of Agriculture – Natural Resources Conservation Service, reported that Gary Kurer, Team Lead, United States Department of Agriculture – Natural Resources Conservation Service, has retired, and that Bird is temporarily filling in. Currently there is a federal hiring freeze, and Bird is unsure when the Team Lead position will be replaced, along with the other current vacancies within the counties on the team. Bird also reported that there is a funding freeze on all federal funds, but USDA programs may have been exempt. There were 32 Environmental Quality Incentives Program (EQIP) applications approved, with about \$600,000 allocated. Projects included grassed waterways, composting facilities, no-till / strip-till, but the funding for these projects is uncertain.

#### Minnesota Board of Water and Soil Resources Report

Ann Gunness, Board Conservationist, Minnesota Board of Water and Soil Resources, introduced herself and reported that she is the new Board Conservationist for the Minnesota Board of Water and Soil Resources, and that she was previously working for the Minnesota Landscape Arboretum. The Minnesota Board of Water and Soil Resources southern region is now fully staffed. Gunness will be covering Dodge, Freeborn, Steele, Mower and Olmsted counties. There is a Soil Health Regional Conservation Partnership Program (RCPP) meeting coming up on February 11, 2025 at the Olmsted SWCD office. Gunness just had a Performance Review and Assistance Program (PRAP) kickoff meeting with Dodge County, and that the mid-plan assessment for the Cedar – Wapsipinicon Watershed is starting.

## **Dodge County Commissioner's Report**

John Allen, Dodge County District I Commissioner, was unable to attend the meeting.

## Treasurer's Report

#### Approval of the Treasurer's Financial Statements, Payment of New Bills

Glenn Hahn, Treasure, presented the December 2024 Financial Report, including the Balance Sheet covering what is in checking and savings, revenues of \$266,780.87 for December and \$746,654.98 for 2024, expenditures of \$46,280.20 for December and \$507,086.25 for 2024, the general ledger and aging summary, with a payables total of \$11,733.33. Adam King, District Manager, explained that quarter 3 and quarter 4 watershed invoices have been processed and sent, are included in the report, and is one of the reasons the revenues are higher than usual this month. King also explained that the second payment for FY2025 SWCD Aid has been received, and also contributed to the higher revenues. King noted the total net income of the district at \$239,568.73 for 2024, and explained that this is usually the time when funds are designated for a 6-month salary reserve, compensated absences, district cost-share, and/or the vehicle/building/equipment fund. The supervisor's discussed the treasurer's report and weather to designate funds. A motion was made to designate an additional \$10,000 to the Vehicle/Building/Equipment fund, an additional \$30,000 to the Cost-Share fund, and an additional \$10,000 to the 6-month Salary Reserve fund.

#### **Employee Re-filing Fees**

Adam King, District Manager, reported that he has not heard back from his CPA on how much the re-filing fees would cost. King advised the supervisors he would present the information as soon as he has the numbers. King also reported that another error has been found with taking the amounts employees contribute to their health insurance premiums after taxes, when they should have been taken out before taxes. Allison English, Administrative Professional, is working on filling out 941-X forms to correct the previously submitted paperwork. Once the amounts are totaled, the district will reimburse the affected employees, and the district will be reimbursed by the IRS. This item has been tabled.

#### Watershed Cost-Share Contract 2024WAGZ-DC-09 (Balzum Revocable Living Trust) Payment

The Muriel Ann Balzum Revocable Living Trust of Dodge Center, MN is requesting cost-share payment from the Dodge Soil and Water Conservation District for a 412 – grassed waterway installed in Section 12 of Wasioja Township. The trust was authorized to encumber \$7,612.96. The trust did not move forward with an optional part of the project, and the final cost of the project was \$26,540.00. \$23,762 was provided in federal funding, and the trust is requesting 90% cost-share between federal and state sources including two acres of preconstruction cover totaling \$300.00, not to exceed \$424.00 from WAGZ Watershed Based Implementation Funding. A motion was made to approve the payment for Watershed Cost-Share Contract 2024WAGZ-DC-09 for the Muriel Ann Balzum Revocable Living Trust for installing a grassed waterway

## **Correspondence & Staff Report**

Adam King, District Manager presented the bound final copies of the 2023 financial audit from Peterson Company, along with the accompanying cover letter. King also discussed the Southeast Regional Groundwater Protection and Soil Health Initiative, presenting the accompanying fact sheet and draft bill to the legislature. The initiative is asking for \$9,000,000 in FY26 and \$9,000,000 in FY27 for implementing a program similar to what Olmsted SWCD has been implementing, including providing an incentive to farmers and producers for establishing a cover crop that is grown to a height of at least 12 inches, and additional ad-on incentives for items such as growing the cover crop to at least 24 inches. The supervisors discussed the program and the draft bill.

## **Supervisor Reports**

## **David Livingston, District IV Supervisor**

David Livingston, District IV Supervisor, reported attending the Cedar River Watershed District Board meeting on Wednesday, December 18, 2024 where the managers reviewed and approved their agreement with the Mower Soil and Water Conservation District, and approved their final budget. The managers also discussed the Southeast Minnesota Nitrogen Legislative Ag and Natural Resources tour. Livingston reported that the projects had been wrapped up, and staff were working on the Reinvest In Minnesota (RIM) and Conservation Reserve and Enhancement Programs (CREP). Livingston also reported attending the Cedar River Watershed District Board meeting on Wednesday, January 15, 2025 where the Dobbins Creek Habitat and Section 319 monitoring grants were discussed. The Orchard Creek access site has been completed, and Tim Ruzek has been working on outreach and the 2024 Annual Report for the Cedar River Watershed District. Livingston said their 2025 tree order form has been released, and that there will be a joint Mower SWCD and Cedar River Watershed District meeting on February 19, but the meeting could be moved to February 12, 2025. Livingston also reported attending the most recent Dodge County Park Board meeting, where there was a motion to disband the Dodge County Park Board, as Dodge County Environmental Services have been handling Dodge County Park issues. The Dodge County Commissioners wants the Dodge County Park Board to continue to provide input on Dodge County parks as the Dodge County Park Committee. The prairie in the county park next to the landfill didn't have much seed in the middle, so the county is going to inter-seed the prairie, and mow walking trails through the prairie. Work continues at the Seminary Ruins, with updating and stabilizing the walls.

#### Glenn Hahn, District V Supervisor

Glenn Hahn, District V Supervisor, reported that there was no County Feedlot Committee Meeting, but did report that the Root River Watershed Policy Advisory Committee will be meeting on Monday, February 24, 2025.

#### Larry Scherger, District III Supervisor

Larry Scherger, District III Supervisor, reported attending the Southeast Soil and Water Conservation District Technical Support Joint Powers Board (JPB)meeting on Wednesday, January 22, 2025 where new officers were elected, projects that JPB staff have been working on were reviewed, and Katie Jacobson, CPA, presented the financial audit for the year ending June, 30, 2024. The JPB is reposting for an engineering technician position, and there were some feedlot funds remaining
