Minnesota Board of Water and Soil Resources Report

David Copeland, Board Conservationist, Minnesota Board of Water and Soil Resources, joined the meeting via MS Teams and reported that the Board of Water and Soil Resources will be losing Assistant Director, Angie Becker-Kudelka. Copeland reported that Greta Gauthier will fill in temporarily in this position. Copeland explained that the Board of Water and Soil Resources (BWSR) is hiring a human resources staff person and it has been at least four years since they have had human resources in-house. Copeland notes that new grants will be going to the next BWSR board meeting, including about \$1 million for this year, and \$1 million for next year for water storage grants. Copeland added that number per year could go up significantly depending on the budget surplus.

Dodge County Commissioner's Report

John Allen, Dodge County District I Commissioner, was unable to attend the meeting.

Treasurer's Report

Approval of the Treasurer's Financial Statements and Payment of New Bills – Samantha Rojo, Administrative Professional, Dodge Soil & Water Conservation District, presented the February 2022 Balance Sheet, Revenues of \$6,070.12, Expenditures of \$44,430.29, the General Ledger, and Aging Summary with a payables total of \$1,797.12. The supervisors discussed the Treasurer's Report. A motion was made to approve the February 2022 Treasurer's Report, and payment of the bills on the Aging Summary, for a payables total of \$1,797.12.

Fuel Fleet Card

Adam King, District Manager, informed the supervisors that an option was found for a fleet card that would not limit staff to fueling at Kwik Trip or Casey's stations, including that with travelling both locally and non-locally to various landowners or trainings, this would be helpful to have in each of our vehicles. King presented the different options relating to the P-Fleet card(s) and the supervisors discussed the options, ultimately deciding it would be best to table the discussion until the next board meeting. The supervisors did instruct King to apply for the P-Fleet account online, and bring the results to the next board meeting.

New Dodge SWCD Logo

The supervisors agreed that the logo update will be tabled until the next board meeting.

Sale of 2005 Dodge Ram 1500

Adam King, District Manager, informed the supervisors that the Dodge Ram 1500 is in need of a new battery, and although he was able to get it started with a jump, the charge would not hold. The supervisors agreed to instruct King to buy and install a new battery for the truck, and get fresh gas put in it so that quotes for selling can be obtained.

Adam King, District Manager, informed the supervisors the grant funds for the BWSR FY2022 Conservation Cost-Share Grant have been exhausted, and the grant needs closing out. King presented the Final Financial Report, with \$9,908.00 spent of \$9,908.00 received, with no funds to be returned to the Board of Water and Soil Resources. <u>Independent Contractor Agreement between the Dodge Soil & Water Conservation District and Mark Moenning</u>

King presented the Independent Contractor Agreement between the Dodge Soil and Water Conservation District and Mark Moenning for operating the Cover Crop Inter-seeder and installing cover crops for anyone who wishes to have cover crops installed on their crop fields. King noted that Mark Moenning will operate his tractor, and the hourly rate from the Minnesota Department of Labor and Industry's prevailing wage (group 6) is \$47.70 / hour. A motion was made to approve Larry Scherger, Board Chair, to sign the 2022 Independent Contractor Agreement between the Dodge Soil & Water Conservation District and Mark Moenning.
