## Approval of the Treasurer's Financial Statements, Payment of New Bills

## 2024 Draft Final Budget

Adam King, District Manager, presented the 2024 DRAFT Final Budget to the supervisors and informed them the budget includes the Dodge County Allocation of \$150,000.00. King relayed that he will be setting up a finance committee meeting to finalize the budget and a final approval can be made at the December 19, 2023 board meeting.
