Approval of the April 16, 2024 The supervisors discussed the April 16, 2024 board meeting minutes. There were no additions or corrections to the minutes. A motion was made to approve the April 16, 2024 Dodge Soil and Water Conservation District's Regular Board of Supervisors Meeting Minutes, as presented.

Partner Agency Reports

Natural Resource Conservation Service Report

Nathan Bird, District Conservationist, United States Department of Agriculture (USDA) - Natural Resource Conservation Service (NRCS), reported that most of the Environmental Quality Incentives Program (EQIP) contracts have been funded, with twenty-two contracts and over \$1 million in the four-county team, including nine contracts and over \$100,000 in Dodge County. Initially there was over \$30 million to spend in EQIP in Minnesota, and an additional \$30 million was received with the possibility of receiving more funding. The NRCS continues to look for projects for a possible batching period in mid-August, with the normal sign-up deadline in the fall. Currently there are ag waste, strip-till/no-till, grassed water ways, basins, as well as the projects that did not receive funding last round. There has also been more interest in forestry practices, particularly those with dead or dying ash trees. The Conservation Stewardship Program (CSP) has 24 contracts in the four-county team, with most being forestry based. Most county offices are conducting Highly Erodible Lands (HEL) and wetland compliance checks to ensure plans are being followed. Pheasants Forever has hired an intern for the office this summer that started on May 13th and will continue to work through mid-August. The intern will be mostly working on habitat projects through the Conservation Reserve Program (CRP).

Minnesota Board of Water and Soil Resources (BWSR) Report

Jill Sackett Eberhart, Board Conservationist, Minnesota Board of Water and Soil Resources, was unable to attend the meeting.

Dodge County Commissioner's Report

John Allen, Dodge County District I Commissioner, was unable to attend the meeting.

Treasurer's Report

Approval of the Treasurer's Financial Statements, Payment of New Bills

Glenn Hahn, Treasurer, presented the April 2024 Financial Report, including the Balance Sheet covering account balances, revenues, expenditures, the general ledger, and aging summary with a payables total of \$12,383.33. The supervisors discussed the treasurer's report, noting the new Certificate of Deposit (CD), and noticed that the information on the profit and loss report was from the wrong year. King stated that he will provide a corrected copy of the financials. A motion was made to approve the April 2024 balance sheet and general ledger, and pay bills on the aging summary for a payables total of \$12,383.33.

Chair Scherger announced moving up the Cover Crop Program Equipment Purchase on the agenda.

Cover Crop Equipment Purchase

Mark Moenning, cover crop contractor, spoke to the supervisors about looking for an inexpensive option to better assist him in the field when planting cover crops. Moenning requested quotes from a few places for equipment, with the best quote coming from the Minnesota Ag Group. Kyle Larson, New and Used Equipment Sales, Minnesota Ag Group, reviewed the quote for a used Trimble 500, and a new Raven CR7, while noting that there is already Raven control unit equipment on the tractor. The supervisors discussed the quote and the options for cover crop program. A motion was made to approve the purchase of a Raven CR7 from the Minnesota Ag Group for the cover crop program.

Unfinished Business

Personnel Committee Recommendations

Adam King, District Manager, informed the supervisors that the Administrative Professional Position and Soil Health Position closed on Monday, May 06, 2024, receiving twelve applications for the Administrative Professional position, and five applications for the Soil Health Conservation Technician position. The Personnel Committee ended up interviewing three candidates for each position.

King informed the supervisors that the Personnel Committee has moved forward with an offer to the top ranked Administrative Professional position candidate, and that negotiations have broken down and no longer would like to be considered for the position. King stated that another candidate that the Personnel Committee previously tried to interview from the past posting has reached back out wondering if the position was still available. The supervisors discussed options, and instructed King to start working with the second candidate that has been interviewed.

King also informed the supervisors that the Personnel Committee has moved forward with an offer to the top ranked Soil Health Conservation Technician candidate, Zachary Colton. Colton has accepted a conditional offer of a grade B23 step 7 plus benefits, and has a proposed starting date of June 3, 2024.

A motion was made to approve hiring Zachary Colton for the Soil Health Conservation Technician at a grade 23 step 7 plus benefits and a starting date of June 3, 2024 contingent on passing a background and reference check, and to make an offer to the next highest ranked candidate that has interviewed for the Administrative Professional position.

Ford F250 Tire Purchase

Adam King, District Manager, informed the supervisors that the Ford F250 needs new tires, and presented quotes from Discount Tire and Fleet Farm. The supervisors discussed the need for and quotes for new tires. The supervisors expressed that they would like to see the purchase be made within the county. A motion was made to approve up to \$1,400 for the purchase of new tires for the Ford F250.

Office Furniture Purchase

Adam King, District Manager, informed the supervisors that new office furniture is needed for the new Soil Health Conservation Technician position, as we do not have a fourth desk. Space dividers are also needed to separate work spaces. The FY24 Dodge Soil Health Staffing grant will cover the cost of new furniture and SWCD Aid funds can be used to if more funds are needed. King presented a quote from National Business Furniture, the same company that furniture was previously purchased, for matching office furniture. A motion was made to approve up to \$8,500.00 for the purchase of new office furniture.

Adam King, District Manager, informed the supervisors that all funds from the FY2024 BWSR Conservation Contracts Grant (P24-0239) have been expended and the grant needs to be closed out. King presented the Final Financial Report, with all \$12,697.00 spent, noting that no funds would be returned to the Minnesota Board of Water and Soil Resources. A motion was made to authorize Adam King, District Manager, submit the Final Financial Report and close out the FY24 BWSR Conservation Contracts Grant (P24-0239) with no funds returned to the Minnesota Board of Water and Soil Resources.

Correspondence & Staff Report

Adam King, District Manager, presented the Minnesota Association of Soil and Water Conservation Districts Resolution Packet, and the Soil and Water Conservation Guide to the 2024 Elections, reminding the supervisors that districts I, II, and V are up for election. King informed the supervisors that he has been working with the Personnel Committee on hiring, along with planning watershed meetings, and carrying out the tree program, and that Jessica Klingfus has been busy in the field surveying and designing conservation projects.

Supervisor Reports

Glenn Hahn, District V Supervisor

Glenn Hahn, District V Supervisor, reported not being able to attend the Root River Watershed Policy Advisory Committee meeting on Monday, May 20, 2024.

David Livingston, District IV Supervisor

David Livingston, District IV Supervisor, reported attending the Cedar River Watershed District (CRWD) board meeting on April 17, 2024 where they had convened a Technical Advisory Committee to review and discuss upcoming projects. A video of a stream restoration project was shared, and Tim worked on the Canoemobile project with the school kids. The district continues to work on a TAP CPL stream restoration project involving multiple landowners and continue to look into water storage grants. Watershed district staff continue to work on the Reinvest In Minnesota (RIM), Conservation Reserve Enhancement Program (CREP), and the Conservation Reserve Program (CRP) and acknowledged that there has never been a better time to sign up for an easement. Livingston also reported attending the Cedar - Wapsipinicon Watershed Policy Advisory Committee meeting on May 1, 2024 where the Mower Soil and Water Conservation District is still waiting for the last 10% of the first Watershed Based Implementation Funding (WBIF) Grant to be reimbursed, and will look at the need of extending the second WBIF grant at the August meeting. It is planned to have a Conservation Tour at the next meeting on August 07, 2024. It was announced that the USDA - NRCS Local Work Group meeting will be held on June 12, 2024 starting at 9:00 a.m. at the Blooming Prairie City Hall. David Livingston continued to report attending the CRWD board meeting on May 15, 2024 where a water and sediment control basin (WASCOB) was approved, the TAP project has started, and there is about \$90,000 still available for projects. The Minnesota Board of Water and Soil Resources (BWSR) provided an update informing the Board of Managers that they are short staffed on the Board Conservationist position. The Canoemobile was a success, with over 700 kids getting out onto the water in canoes. Even with all the recent rains, soil borings for projects have shown that there is less moisture in the soils than originally thought.
