Partner Agency Reports

Natural Resource Conservation Service Report

Nathan Bird, District Conservationist, United States Department of Agriculture (USDA) - Natural Resource Conservation Service (NRCS), reported that staff are working on the Conservation Stewardship Program (CSP) with status reviews completed and are now looking at specific practices. Bird reported that there are thirteen Environmental Quality Incentives Program (EQIP) projects in Dodge County, that there is an updated review process this year, and four projects have been signed off on so far. Bird is still assisting with the workload in

Steele County until June, with Soil Conservationist positions being advertised for Steele and Freeborn Counties. Pheasants Forever has an intern that will be housed in the Dodge Center Service Center that will be starting May 15, 2024 and working through August. The intern will mostly be working on grassland and habitat practices. The USDA – NRCS has funded a "Conservation Through Retail" grant for Truterra / Land O' Lakes that will cover multiple counties in Minnesota including Dodge, Mower, Freeborn, Steele, and Rice. The grant partners with cooperatives including Central Farm Service (CFS), and Nexus and they will be hiring Conservation Agronomist positions to serve the area.

Minnesota Board of Water and Soil Resources (BWSR) Report

Jill Sackett Eberhart, Board Conservationist, Minnesota Board of Water and Soil Resources, was unable to attend the meeting.

Dodge County Commissioner's Report

John Allen, Dodge County District I Commissioner, was unable to attend the meeting.

Treasurer's Report

Approval of the Treasurer's Financial Statements, Payment of New Bills

Glenn Hahn, Treasure, presented the March 2024 Financial Report, including the Balance Sheet covering account balances, revenues of \$32,623.98, expenditures of \$18,002.20, the general ledger, and aging summary with a payables total of \$923.81. The supervisors discussed the treasurer's report, including the KMTelecom invoice which has increased with the addition of fiberoptic internet. A motion was made to pay the KMTelecom monthly invoices at the increased rate of \$109.99 as they are received.

A motion was made to approve the March 2024 Treasurer's Report, and pay bills on the aging summary for a payables total of \$923.81.

The supervisors continued to discuss Certificates of Deposit (CD) rates. King provided information on CDs at the two approved financial institutions. A motion was made to authorize \$100,000 from the Heritage Bank account to be moved into a Certificate of Deposit for no more than six months at an interest rate of no less than five percent.

Unfinished Business

Personnel Committee Recommendations

Adam King, District Manager, informed the supervisors that the he attempted to set up interviews with the top five candidates for the Administrative Professional position. An additional candidate applied that ranked highly, and the Personnel Committee asked for an interview. Three of the candidates never responded, and interviews were set up with the other three candidates. Two candidates withdrew prior to their interview, and the Personnel Committee conducted one interview. It was felt that the candidate was well qualified and well suited

for the position, which King offered to the candidate. The candidate declined, stating she did not want to be in a position that was mostly accounting or bookkeeping.

The Personnel Committee met again to discuss the position. The Personnel Committee is recommending removing the Administrative Professional B31 grade from the wage scale making all positions under the District Manager a B23 grade, and reposting the position.

The Personnel Committee also discussed receiving the BWSR Soil Health Staffing grant to build soil health capacity within the district. The Personnel Committee reviewed the position description and wage scale for the new Soil Health Conservation Technician position. The Personnel Committee is recommending posting for a Soil Health Conservation Technician position.

A budget for promoting the positions was discussed at the Personnel Committee meeting. This would allow the district to be able to sponsor positions on job websites, and promote the postings elsewhere. The Personnel Committee is recommending a budget of \$250.00 per position for advertising the position postings.

A motion was made to approve posting for an Administrative Professional position, and posting for a Soil Health Conservation Technician position, with both positions at a B23 Grade and closing on Monday, May 06, 2024, with a budget of \$250.00 per posting for promoting the postings.

The estimated cost for the practice is \$26,840.00, and is requesting to encumber up to 90%, not to exceed \$24,606.00. The estimated cost for the practice is \$5,025.00, and is requesting to encumber up to 13%, not to exceed \$674.50, with 3 acres of pre-construction cover at \$150 per acre for an additional \$450.00 and a total encumbrance of \$1,574.50. The estimated cost for the practice is \$39,604.40, and is requesting to encumber up to 18%, not to exceed \$7,612.96, with 2 acres of pre-construction cover at \$150 per acre for an additional \$300, and a total encumbrance of \$7,612.96. King explained that the majority of the grant will be used to fund the new Soil Health Conservation Technician position, with a small amount available for administration and equipment/office supplies costs. A motion was made to authorize Adam King, District Manager to sign and submit the grant agreement for the FY24 BWSR Dodge Soil Health Staffing Grant totaling \$382,500.00.
