Natural Resource Conservation Service Report

Nathan Bird, District Conservationist, United States Department of Agriculture (USDA) - Natural Resource Conservation Service (NRCS), reported that thirty applications for the Environmental Quality Incentives Program (EQIP) were received in Dodge County, with the applications being for a variety of practices. Overall, ninety-five applications were received for the four-county team, and there is a possibility of an EQIP sign-up in the spring, depending on funding. Then Continuous Conservation Reserve Program (CCRP) has opened again and is currently

David Livingston, District IV Supervisor, reported attending the Cedar River Watershed District Meeting where a stream restoration was discussed. Bids for the project have been received, with the Minnesota Department of Natural Resources approving the design from WSB. The district has received a grant from the Hormel Foundation, and Hodgman will be working on a basin project. A grassed waterway project in Red Rock Township in the Dobbins Creek watershed is ongoing, with most projects completed for the year. There are two wetland restoration projects, and they are working with Runnings for a kayak they will be raffling off. The Minnesota Board of Water and Soil Resources has received \$25,000,000 from the State of Minnesota, and has been awarded a \$25,000,000 Regional Conservation Partnership Program for soil health.
