Treasurer's Report

Approval of the Treasurer's Financial Statements and Payment of New Bills – Glenn Hahn, Treasurer, presented the January 2022 Balance Sheet, Revenues of \$20,948.41, Expenditures of \$37,566.11, the General Ledger, and Aging Summary with a payables total of \$15,589.05. The supervisors discussed the Treasurer's Report. A motion was made to approve the January 2022 Treasurer's Report, and payment of the bills on the Aging Summary, for a payables total of \$15,589.05. David Livingston abstained from voting.

New Dodge SWCD Logo

New Business

FY19 Buffer Law Implementation Grant Close-Out

Adam King, District Manager, informed the supervisors the grant funds for the BWSR FY2019 Buffer Law Implementation Grant have been exhausted, and the grant needs closing out. King presented the Final Financial Report, with \$25,122.31 spent of \$25,000 received, with no funds to be returned to the Board of Water and Soil Resources. A motion was made to authorize Adam King to sign and submit the BWSR FY19 Buffer Law Implementation Grant final Financial Report, with \$0.00 returned to the Board of Water and Soil Resources.

King notes that Paul Kiltinen, Dodge County Attorney, has also reviewed the document and sees no issues. A motion was made to approve Adam King to sign and execute the Unfunded Cooperative Agreement with United States Department of Agriculture – Natural Resource Conservation Service.

2022 Joint Powers Agreement Between the State of Minnesota Department of Natural Resources and the Dodge Soil & Water Conservation District for Walk-In Access

Adam King, District Manager, presented to the supervisors The Minnesota Department of Natural Resources Joint Powers Agreement with the Dodge Soil and Water Conservation District for the Walk-In Access Program for 2022. King explains this JPA will allow the Dodge SWCD to enroll landowners in the Walk-In Access Program, and also explains this was an agreement we signed into last year. King notes that funds to the district will not exceed \$1,000, with \$250 being provided for each contract. A motion was made to approve Larry Scherger, Board Chair, to sign the 2022 Joint Powers Agreement Between the State of Minnesota Department of Natural Resources and the Dodge Soil & Water Conservation District for Walk-In Access.

District Cost-Share Contract 2022-01 (Fay) Encumbrance

Marlin Fay of Grand Meadow, MN has requested cost-share assistance from the Dodge Soil and Water Conservation District for the installation of a 412-Grassed Waterway in Section 28 of Vernon Township. The estimated cost for the practice is \$7,661.50, and Fay is requesting to encumber 65%, not to exceed \$4,979.98. A motion was made to approve the encumbrance of district cost-share contract 2022-01 for Marlin Fay for the installation of a 412-Grassed Waterway at 65% of the total cost of the project, not to exceed \$4,979.98. District Supervisor, Glenn Hahn, abstained from voting on this project.

Adam King, District Manager, explains that Goodhue County SWCD has developed a Sub-Agreement to distribute the funds to the member LGUs for technical and financial assistance with the Watershed Based Implementation Funding – Watershed Alliance for the Greater Zumbro (WAGZ). King notes that many of the funds will be used as passthrough to the member LGUs for financial and technical assistance for the implementation of conservation practices. King informs the supervisors that Goodhue County SWCD is the fiscal agent for the grant, will receive the funding of the grant, and will be invoiced quarterly for worked performed / funds paid out for cost-share. A motion was made to approve the Dodge Soil & Water Conservation District to sign and submit the Sub-Agreement between the Goodhue County Soil and Water Conservation District and the Dodge Soil and Water Conservation District for Watershed Based Implementation Funding.
