John Allen, Dodge County District I Commissioner, was unable to attend the meeting.

Treasurer's Report

Approval of the Treasurer's Financial Statements, Payment of New Bills

Adam King, District Manager, presented the October 2022 Financial Report, including the Balance Sheet, Revenues of \$9,899.45, Expenditures of \$24,696.13, the General Ledger and Aging Summary, with payables total of \$744.08. The supervisors discussed the treasurer's report. A motion was made to approve the October 2022 Treasurer's Report, and payment of the bills on the Aging Summary, for payables total of \$744.08.

Unfinished Business

Dodge Soil and Water Conservation District Policy Handbook

Adam King, District Manager, explained that work continues on the Dodge Soil and Water Conservation District policy handbook. King and the supervisors discussed the cover crop program as a whole and whether or not to charge a fee to the landowners participating in planting cover crops. The topic of disposing of or selling district property over a certain value was also discussed, King is to make updates to the Operations section of the handbook (page 22) and hopes to have a full draft for the supervisors to review at the December 20th meeting.

New Business

2023 Draft Final Budget

Adam King, District Manager, presented the FY2023 Draft Final Budget, noting that the changes made from the prior versions can be found in the far-right column for each account. A finance committee meeting was set for December 6th to further discuss and finalize the final budget.

Joint Powers Agreement between the Minnesota Department of Agriculture and the Dodge Soil and Water Conservation District for Woodchip Bioreactor Amendment

Adam King, District Manager, presented the Joint Powers Agreement between the Minnesota Department of Agriculture and the Dodge Soil and Water Conservation District for Woodchip Bioreactor Amendment. King explained that we will need to extend the agreement for one year and add an additional funding of \$1,625.00 to the budget to cover next year's anticipated cost. A motion was made to approve the amendment, and for Adam King to sign the Joint Powers Agreement between the MN Department of Agriculture and the Dodge SWCD for Woodchip Bioreactor Amendment via DocuSign.

Technology Subscriptions

Adam King, District Manager, explained that staff are still using many of the technology subscriptions purchased in the last year. King presented the proposed technology subscriptions from staff who recommend keeping WeWorked as our time keeping program for an additional \$60/year, keeping DocuSign at no cost increase, the Microsoft account to include Teams, One Drive, and Sharepoint for an additional \$1.00/employee/month (\$36.00/year), and Adobe Acrobat Pro for an additional \$60/year. King also added that an annual fee of \$589.49 for QuickBooks Pro is recurring in October as well. The costs of each program are outlined below:

Adam King, District Manager, informed the supervisors that the Conservation Corps Minnesota & Iowa (CCMI) is accepting applications for hosting individual placements and he is interested in applying. Discussion regarding what type of work the individual placement would do for the district was had; Adam King feels that outreach for special projects and/or general outreach would be a good avenue for a placement. King would like to apply for a placement for approximately 3 months in the summer. A motion was made to approve Adam King to apply to the CCMI for an individual placement.

District Cost-Share Contract 2022-05 (Trust B of Lloyd Wobbrock Trust) Amendment

Trust B of Lloyd Wobbrock Trust of Claremont, MN is requesting an amendment to the District Cost-Share Contract 2022-05; the estimated cost of the practice was \$1,845.00, but the actual cost of the well decommissioning came to \$2,510.00, with half being \$1,255.00. A motion was made to approve the additional encumbering of \$332.50 to bring the cost-share amount up to \$1,255.00, fifty percent (50%) of the actual eligible costs.

District Cost-Share Contract 2022-05 (Trust B of Lloyd Wobbrock Trust) Payment

Trust B of Lloyd Wobbrock Trust of Claremont, MN has requested cost-share payment from the Dodge SWCD for the installation of a 351-well decommissioning in Section 29 of Claremont Township. The total cost of the practice installation was \$2,510.00 and Trust B of Lloyd Wobbrock is requesting fifty percent (50%) of that amount, not to exceed \$1,255.00. A motion was made to approve the payment of district cost-share contract 2022-05 for Trust B of Lloyd Wobbrock Trust for the installation of a 351-well decommissioning at 50% of the total cost of the entire project, not to exceed \$1,255.00, using state cost-share funds from the FY20 Local Capacity Services Grant.

District Cost-Share Contract 2020-11 (Shubert) Payment

Gilman Shubert of Kasson, MN has requested a cost-share payment from the Dodge Soil and Water Conservation District for the installation of a 412-Grassed Waterway in Section 15 of Canisteo Township. The total cost for practice installation was \$6,737.80 and Shubert is requesting 65% of that amount, not to exceed \$4,379.57. A motion was made to approve the payment of district cost-share contract 2020-11 for Gilman Shubert for the installation of a 412-Grassed Waterway at 65% of the total cost of the entire project, not to exceed \$4,379.57, using state cost-share funds from the FY20 Local Capacity Services Grant.

FY23 Conservation Delivery Grant Closeout

Adam King, District Manager, explained the grant funds for the BWSR FY2023 Conservation Delivery Grant (P23-5589) have been exhausted and the grant will need to be closed out. The total funding from the grant was \$19,343.00, and all funds were spent on administration of the Dodge SWCD. King added that no funds will be required to be returned to the Board of Water and Soil Resources. A motion was made to authorize Adam King to sign the final Financial Report and submit the grant close-out to the Board of Water and Soil Resources.

Adam King, District Manager, informed the supervisors about the respective hard copies of the 2021 audit in their folders. King also shared the MN Department of Agriculture's 2021 Greenbook with the supervisors, which highlights all the Department of Agriculture's grants and projects that came from funding that year. King explained that Jessica Bakken, District Technician, and Samantha Rojo, Administrative Professional, attended the 2022 BWSR Academy training, and Jessica is working on finishing up projects and getting final surveys done on the ground.

David Livingston, District IV Supervisor

David Livingston, District IV Supervisor, reported attending the most recent Cedar River Watershed District (CRWD) Meeting, where they had little for payables as activity has been static the past couple of months. Livingston noted that the MPCA (MN Pollution Control Agency) has taken over the 2 new I-90 permits so the CRWD will no longer have a say in those projects which are assumingly going to be culverts. Livingston added that the Nature Center in Austin has great information on the Mussels and shed light on how they are working to make a comeback of them.

Livingston also reported attending the November 2nd Cedar River 1W1P Policy Committee meeting where they went over budget items and discussed the Stressor ID (SID) update for the Dobbins Creek project.
